After the Lancet peer-review process, participants will be informed of acceptance of abstracts for oral or poster presentation by Aug 27, 2014. ### **EUPHA supports the Global Convention to Protect and Promote Healthy Diets**

EUPHA is pleased to be an official supporter of the call for a globally binding treaty to improve diets made by the World Obesity and Consumers International. The call to the international community is to develop a global convention to fight diet-related ill health, similar to the legal framework for tobacco control. Unhealthy diets now rank along with tobacco and alcohol as the three leading causes of disease and early death globally. The jointly published report 'Recommendations towards a Global Convention to protect and promote healthy diets' calls for government commitment to introduce a raft of policy measures designed to help consumers make healthier choices and improve nutrition security for everyone and is published on May 19th and launched at a side event of the World Health Assembly in Geneva on May 21st.

### **University of Porto: applications period for new Global Public Health Doctoral Programme**

We would like to inform you about the ongoing applications period for new Global Public Health Doctoral Programme which will start in October 2014. The first phase of applications will run until the May 23rd and the selection results will be published on June 16th.

The new Doctoral Programme will select a maximum of 16 candidates with 10 being eligible for an FCT (Portuguese Foundation for Science and Technology) scholarship.

This training offer is the result of a consortium established by four Portuguese schools - Institute of Public Health and Faculty of Medicine of the University of Porto, as well as National School of Public Health, Faculty of Medical Sciences and Institute of Hygiene and Tropical Medicine of the Lisbon NOVA University - with the aim to compete internationally in teaching and research in Public Health.

## **4. Interesting News**

### **Tackling health inequalities: the MASCOT vision**

Health inequalities are still affecting women and children in many areas of the world. The **MASCOT** project aimed at enhancing understanding and dissemination of strategies for addressing these inequalities through international co-operation.

MASCOT brought together 11 partners and 3 world regions (Europe, Africa, and Latin America) to work towards selected targets. These included mapping the current status of maternal and child health inequalities in selected countries, identifying the best practices that should be implemented for tackling inequalities, and fostering multilateral collaboration and knowledge transfer.

Among the many results/outcomes produced, an open source, freely searchable **webDatabase** has been developed that covers research on maternal health in low- middle- and high-income countries.

### **Making fair choices on the path to universal health coverage**

Final report of the WHO Consultative Group on Equity and Universal Health Coverage  
Universal health coverage (UHC) is at the center of current efforts to strengthen health systems and improve the level and distribution of health and health services. This document is the final report of the WHO Consultative Group on Equity and Universal Health Coverage. The report addresses the key issues of fairness and equity that arise on the path to UHC. As such, the report is relevant for every actor that affects that path and governments in particular, as they are in charge of overseeing and guiding the progress toward UHC.

This report addresses the critical choices of fairness and equity that arise on the path to UHC. Accordingly, the report is not primarily about why UHC ought to be a goal, but about the path to that goal. The report may differ from others in the direct way it addresses fundamental issues and difficult trade-offs. This approach was facilitated by the involvement of philosophers and ethicists in addition to economists, policy experts, and clinical doctors.

[New websites on migration and Roma health](#) 25-04-2014 An estimated 73 million migrants and 10–12 million Roma live in the WHO European Region. The European health policy framework, Health 2020 calls for the creation of supportive environments and resilient communities as one of its four priority areas for policy action. Improving the conditions in which migrants and Roma populations live, grow, work and age is a key factor in improving their health and well-being, as well as reducing the health inequalities in the Region. WHO/Europe has launched two new websites to share information about improving the health of both migrants and Roma populations.

[Malaria: great progress towards elimination, but persistent threat of imported cases and reintroduction](#) 25-04-2014 The WHO European Region aims to interrupt the transmission of malaria and eliminate the disease by 2015. Vector surveillance and control, and the early detection of cases in human beings are vital to prevent the reintroduction and re-establishment of mosquitoes, and the spread of the diseases they carry. 5000 cases were imported into the Region in 2013, and the threat of reintroduction of the disease remains.

[Paris declaration on green and healthy mobility and transport signed](#) 15-04-2014 On 15 April 2014, European ministers attending the Fourth High-level Meeting (4HLM) on Transport, Health and Environment, adopted the Paris Declaration: City in Motion – People First!. The Declaration sets priorities and calls for action to ensure green and healthy mobility and transport to secure sustainable livelihoods for all.

[Press release: Cycling can create at least 76 600 jobs and save 10 000 lives every year in major European cities](#) 14-04-2014 Over 76 600 people would be employed in green and healthy transport every year and 10 000 lives would be saved if major European cities reached the cycling modal share of Copenhagen. This is the conclusion of a new publication released today by UNECE and the WHO Regional Office for Europe.

[Third European Roma Summit calls for integration at local level](#) 11-04-2014 Around 500 representatives of European Union (EU) institutions, national governments and parliaments, international organizations, civil society (including Roma organizations), local and regional authorities and mayors gathered in Brussels on 4 April 2014 to take stock of progress made on Roma inclusion in the EU.

[Hepatitis C treatment guidelines issued](#) 09-04-2014 WHO has issued its first guidance for the treatment of hepatitis C, a chronic infection that affects an estimated 130 million to 150 million people and results in 350 000 to 500 000 deaths a year worldwide. An estimated 1 in 50 people is infected with hepatitis C in the WHO European Region. The publication of the "WHO guidelines for the screening, care and treatment of persons with hepatitis C infection" coincides with the availability of more effective and safer oral hepatitis medicines, along with the promise of even more new medicines in the next few years.

[New resources support laboratory quality management](#) 28-03-2014 To help laboratories implement systems to manage quality control, WHO recently launched a suite of resources in several languages.

[Unlocking new opportunities: jobs in green and healthy transport](#) This publication focuses on potential job creation from public transport, cycling and walking. An analysis of the available evidence suggests that these modes could be significant employers and contributors to the green economy.

[Developing national action plans on transport, health and environment. A step-by-step manual for policy-makers and planners](#) This manual was developed to guide national transport, health and environment action plan (NTHEAP) development by countries. It proposes four phases: planning, development, implementation and evaluation. It does not provide specifics on how to establish general policies or strategies on sustainable and healthy transport, an activity that usually precedes the development of NTHEAPs. The manual provides practical advice on each of the phases (and the steps that comprise them) in an NTHEAP and highlights good practices from the European Region.

[From Amsterdam to Paris and beyond: the Transport, Health and Environment Pan-European Programme \(THE PEP\) 2009-2020](#) This report encapsulates the past 12 years of progress made under THE PEP since its launch in 2002. The report underlines some of the achievements between the adoption of the Amsterdam Declaration in 2009 at the Third High-level Meeting on Transport, Health and Environment (3HLM) and the 4HLM held in Paris, France in 2014.
